# What is an Enrolled Agent?

Enrolled Agents (EAs) are tax practitioners with technical expertise in taxation, who have earned the privilege and are federally authorized to prepare taxes and represent taxpayers before all administrative levels of the Internal Revenue Service (IRS) including audits, collections and appeals.

- Enrolled Agents are regulated by the Department of the Treasury to represent taxpayers before the IRS for audits, collections and appeals.

- Enrolled Agents must fulfill continuing tax-centric education requirements.

# Requirements to Become an Enrolled Agent

Applicants must:

- Pass either the Special Enrollment Exam (SEE) or have specific employment experience with the IRS to be licensed.
- Pass a background check.

- Administered by the Department of the Treasury in conjunction with Prometric.
- An applicant's knowledge of taxation is tested in the areas of individuals, businesses and representation, practice & procedures.

# IRS Experience Can Substitute for the Special Enrollment Exam

- The IRS employee must have five or more years of experience with the IRS.
- IRS experience must be in a position that regularly interprets and applies the Tax Code.
